9.2 Project Homeland-Donna received items from parishioners plus \$40. We agreed to have two Masses said for our military... one for deceased warriors and one for living warriors. Since the military has returned from Afghanistan, we must send packages to a named military personnel at his address in a peacekeeping country. Carol advised that Signals have been sent back to Canada and things are at an in between stage presently. She informed us of a Queen's University research program regarding military and veterans suicides and mental problems. This program is trying to reach all universities across Canada, U.S., Great Britain and other countries. It has been discovered that Guide dogs are helping a lot of veterans with PTSD. The Wounded Warriors are working on getting guide dogs and funding for this project.

There will be further investigation with regard to Project Homeland.
